In case of false/wrong declaration or fabricated documents have been used for procuring permissions of MARB and any misconduct is brought to the notice of National Medical Commission (NMC) or found during surprise assessment at any stage during the current academic year, your institution is liable, not to be considered for recognition of that degree.
