- Outcome of the training (250 words)

Through this celebration more than 460 stake holders were engaged in the events conducted. Knowledge about pharmacovigilance was spread across all the stake holders including doctors, nurses, technicians, medical students, pharmacists, post graduates and general public.

Day 1 outcome:

Program was inaugurated in presence of chief of NCC-IPC Dr Jai Prakash on 17-Sep-2021 and followed by his talk on "**Reporting of ADRs to Regulatory Actions: PVPI experience**". Dr Jai Prakash

mentioned that "ADRs can be reported by doctors, pharmacists, lab technicians, researchers, physiotherapists, nurses including general public. More than 400 ADR Monitoring Centers (AMCs) identified across the country and are working in association with NCC-IPC. All the reports received by the AMCs are uploaded to World Health Organization (WHO) database (VigiFlow). The data received through this process is further processed to identify the risks and the associated drugs. Drug Regulators office issues safety alerts to the pharma companies time to time based on these results. Through this we are able to restrict the use of risky drugs and remove drugs from market which are found to cause fatal events. Therefore all the stakeholders should take it seriously to report ADRs" he informed. Series of events followed after his talk including talk by Dr Dr Madan Gaikwad Special officer, Dr Rajagopalan S Vice Principal and Medical Director and Dr Abhiram R Assistant professor, department of Dermatology. All the dignitaries encouraged reporting of ADRs and stressed the importance this activity in preventing them.

Faculties of department of pharmacology, CDSIMER under the leadership of Dr Pratibha Nadig, the organizing chairman and Dr Shiva murthy N, the organizing secretary, organized various competitions on the occasion of National Pharmacovigilance week CME events. E-Poster competition on “**adverse drug reactions related case reports**” for doctors and “**preventions of medication errors or Rational drug use for patient safety**” for paramedical staff were organized. The main theme of these competitions was “**Patients Safety through Pharmacovigilance and Prevention of ADRs**”.

Participants from various parts of India including Karnataka, Maharashtra, Tamil Nadu, Telengana, Andra Pradesh, Puducherry, Himachal Pradesh, Uttarkhand, Assam, Punjab, Rajasthan, Haryana, Bihar, Orissa and West Bengal. Organizers also received great response from well known institutions such All India institute of Medical Science (AIIMS) Rishikesh, Jawaharlal Nehru Institute of Medical Education and Research (JIPMER) Puducherry, Bangalore Medical College (BMCRI) Bangalore, DY Patil medical college Puna and Navi Mumbai, and JSS medical college Mysore. Huge amount of response was received from medical colleges of Karnataka located at Bangalore, Mysore, Mandya, Hasan, Tumkur, Belgaum and Bellary. Faculty members and students from CDSIMER also participated in all the competitions. The assessment of entries received for all the events were done on 18-Sep-2021 and 20-Sep-2021. Dr Venkatesh Murthy (Prof and HOD of Anesthesiology), Dr Pratibha Nadig (Prof and HOD of Pharmacology), Dr Mukund (Onco-surgeon), Dr Avinash (Orthopedician), Dr Nagendra Prasad (Prof and HOD of OBG), Dr Anil Kumar H (Prof and HOD of Medicine) judged the events and winners were decided for these competitions.

Public awareness and engagement program was conducted on 22-Sep-2021 with a streetplay at CDSIMER hospital located at Devarakaggalahalli, Harohalli, Ramanagara district. The well known pediatrician Dr Asha Benakappa (Prof and HOD of Paediatrics) was the chairperson for this event. Staff of Department of Pharmacology enacted this play. Story of patients who complained signs and symptoms of adverse drug reactions, method of identification, reporting to doctors and NCC-IPC was enacted to educate the public. Doctor role was played by Dr Vinshu K, Nurse role by Dr Padmaja Shetty K, Pharma company representative role by Dr Deepak M, Patient role by Dr Raghavendra B and patient sister role by Dr Anusha SJ. The story script by Dr Shiva Murthy N and Direction and Dialogues was by Dr Raghavendra B. A song written and sung using folk tune by Dr Shiva Murthy N was used in this play. Dr Asha Benakappa informed the patients and public who attended the program that "ADRs identification is very important especially in children and elderly patients. Self medication in children can be dangerous and it may affect various important organs like kidney, liver and eyes etc. She insisted not to do self medication and all the unused medications should be discarded properly. **Expired drugs also can cause life threatening adverse events**" she added. Dr Pratibha Nadig in her closing remarks, encouraged all patients, their relatives and general public to report ADRs using toll free number 1800 180 3024 or report to CDSIMER AMC using E mail id amc.cdsimer@dsu.edu.in.

Valedictory function of **National Pharmacovigilance Week CME Events** was conducted on 23-Sep-2021 with the gracious presence of Honorable Vice Chancellor of Dayananda Sagar University (DSU) Dr K N Balasubramanya Murthy, Dr Ashok AC (Dean and Principal), Dr Rajagopalan S (Vice Principal and Medical Director) and Dr Madan Gaikwad (Special officer). The event started with welcome by Dr Pratibha Nadig. She mentioned that more than 400 ADR monitoring centers (AMCs) are working across the country and through these centers data collected are entered into the WHO database. Through this India is one the major supplier of safety information about drugs to WHO both by quality and quantity. Due to this, NCC-IPC is able to issue safety alerts and warnings to pharma companies operating in India. She also shared her experience in changing prescription practices and change in preferred drug status for various drugs due to Pharmacovigilance activities. Dr AC Ashok mentioned in his talk about various drugs that were removed from market due to their serious and intolerable adverse drug effects. Dr KNB Murthy addressed the gathering and stressed on the importance of pharmacovigilance activities. "Vigilance (meaning be alert, take care to guard) is required to safeguard the general public and patients from risks posed by Drugs" he added. Drugs are subjected to strict evaluation in animals (preclinical evaluation) and clinical evaluation (phase 1-3 trials). But they are conducted in pre-decided conditions. Clinical Trials alone cannot detect all the adverse drug reactions due to limitations of their own. Therefore general public need to be alert and report each and every adverse drug reactions if they experience. Dr KNB Murthy mentioned that "not only drugs needs vigilance, all the goods, services, activities, needs monitoring to prevent corruption, improve quality, adherence to standards, and ensuring right steps are taken at right time to prevent adverse consequences to general public. Drugs are used for saving lives when patient is on hospital bed. He or she are in badly need of drugs to survive from the poor health condition. We cannot afford to have poor quality or risky drugs" he added. In the recent past, technology has intruded into all parts of our life. Mobile phone and softwares are specially finding their place in various diagnostic and therapeutic activities in hospitals. Artificial intelligence and computing technologies are changing the way we are going to live in the future. Considering these changes, **"Materiovigilance" (vigilance on machines and softwares and other equipments used in healthcare)** will be next big thing that need consideration" he added. Dr KNB Murthy distributed prizes to winners of various competitions held as a part of the National Pharmacovigilance week CME events. The list of winners are as given below:
